# Excellence in Surface Coal Mining Reclamation Awards

### About the Awards

The Excellence in Surface Coal Mining Reclamation Awards are presented to coal mining companies that achieve the most exemplary coal mine reclamation in the nation. Past winners have demonstrated a commitment to sound mining practices and effective reclamation plans that enhanced beneficial post-mining use of the land. OSMRE has honored high quality coal mine land reclamation since 1986.

### Eligibility

Surface coal mining and reclamation operations conducted under a Title V permit (1978 - present) may be nominated for an award. In addition, non-permitted mining and reclamation completed using government financial reclamation contracts under the Enhanced Abandoned Mine Land regulations is eligible for nomination. Abandoned mine land reclamation projects carried out exclusive of active mining are not included in this program. If integrated with Title V permitted operations, AML projects are eligible for a national award.

### Award Categories

OSMRE presents two awards each year. A **National Award** recognizes achievement in a specific aspect of reclamation or for overall performance in meeting goals of SMCRA. The nominated activity must have been performed within the past five years. The **Good Neighbor Award** is given to mine operators for successfully working with the surrounding landowners and the community while completing mining and reclamation. The nominated activity must have been performed within the past three years.

### Scoring Nominations

A panel of OSMRE judges evaluates nominations in the following categories:

#### **National Award:**

- Difficulty of project and onsite effectiveness.
- Creativity and ingenuity.
- Transferability of the technique or practices used.
- Exceeds the spirit and intent of SCMRA.

#### **Good Neighbor Award:**

- Difficulty of project and onsite effectiveness.
- Increased public awareness of SMCRA.
- Long-term benefits to the community.
- Exceeds the spirit and intent of SCMRA.

### Site Visit & SMCRA Compliance Check

An OSMRE representative will conduct a site visit to ensure on-the-ground performance conforms with the permit and is exemplary within that state or geographic area, information in the nomination accurately reflects current site conditions, and other mining activities at the site do not detract from award-winning activity. Nominee's surface mining law compliance record is examined to ensure that there are no outstanding violations and to determine that there is no past record of not abating violations.

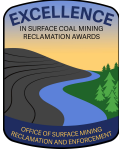
### Deadline & How to Submit Your Nomination
