## **Five State Regulatory Agencies, Six Mining Companies Win Reclamation Awards from the Office of Surface Mining Reclamation and Enforcement**

(Washington, D.C.) – They represent the best of American mining and reclamation efforts in the coal mining industry and state and tribal regulatory programs. This fall, the U.S. Department of the Interior’s Office of Surface Mining Reclamation and Enforcement (OSM) will recognize the accomplishments of several state regulatory agencies and mining companies under the Surface Mining Control and Reclamation Act (the Surface Mining Act).

OSM is pleased to announce the winners of the 2010 Abandoned Mine Land Reclamation Awards and the 2010 National Awards for Excellence in Surface Mining.

“In considering the nominees for these awards, we take into account their practice of protecting the environment over the long term,” said OSM Director Joe Pizarchik. “OSM believes it is important to recognize a job well done, and these state agencies and companies have demonstrated the importance and benefits of reclamation, as envisioned in the Surface Mining Act.”

**The Abandoned Mine Reclamation Awards** recognize outstanding abandoned mine land reclamation in the United States and showcase exemplary reclamation techniques. Only projects funded wholly or in part and completed by approved state or tribal regulatory programs are eligible to win. Past award winners have encompassed all types of reclamation, including coal, non-coal, and emergency projects. A panel of judges comprised of directors of state reclamation programs and certain OSM managers, vote to determine the winners.
